Let's move on as I was sentenced under them, while five been on various networks in refusal to self-defense in any of these cases, and a desire then to waive the remainder of any wrestling or wrangling in them.

Now I have addressed this matter for at least 2 months to your Honorables as well as State Attorneys, and Capital Collateral Representatives that as you know instantly take over appeals, yet I've received "No Response" to my "Constitutional Rights" to "Waive" as so desired. And so I am asking here then for the Florida Supreme Court to step in and "Do something" with this "Violation of" Requesting if I may a hearing on them to conclude and finalize this gap.

And I also understand I've need be evaluated before the court can approve such, while I say: fine and dandy, as be it, and if you'd like I'll be more than happy to take a polygraph too, just so matters are that much more justified before proceeding. While I'd also like to request "Legal Assistance" in this so that all things can be properly filed for the courts, since I'm indigent for private counsel. In the meantime I'd appreciate a response in writ, that this letter has reached you and what next then the court intends to do. Thank you for your time.
